Eastern Devon Population Health Partnership Meeting

Minutes of the meeting of the Eastern Devon Population Health Partnership Meeting held on Wednesday 28 May 2025 from 1500 – 1630 via MS Teams

Agenda Item

1 Welcome and introductions

JC welcomed attendees and outlined the meeting's purpose, which was to review the outcomes of the 2025/26 ICB health inequalities and population health funding round, receive an update on OED finances, and briefly reflect on 2024/25 investments. He also acknowledged the challenging wider context facing the NHS and ICB, including ongoing financial constraints.

2 Review of notes and actions

There were no changes to the previous minutes. JC reviewed the action log, confirming progress against several key items and updating the group on a few ongoing strands of work.

3 2025/26 ICB Funding for Health Inequalities/Population Health

- JC summarised the allocation of £515,000 ICB funding for 2025/26. £190,000 had already been allocated to existing areas including the HIU ED service (£60k), paused social prescribing initiative (£25k), VCSE coordination (£33k), and other capacity-building support. The social prescribing post is under review following the staff member's departure, with questions around future delivery. The VCSE Backfill Fund was significantly underused (only £5k spent), indicating a need to reassess that offer.
- A highly competitive funding round followed, with 38 bids submitted requesting over £1.8m. A panel used a multi-criteria matrix aligned to ICB and OED strategy to assess proposals. Eight projects were recommended, including those led by Citizens Advice, Age UK Exeter, Devon Mental Health Alliance, and Parental Minds. Themes included mental health, community-led delivery, and support for underserved rural and coastal areas.
- The group discussed funding gaps around unpaid carers, neurodiversity, ethnic minority inclusion, digital exclusion, and falls prevention. JC flagged the importance of future prioritisation and improved governance processes for the Partnership.

Action: JC to raise £5k reduction to VCSE Backfill Fund at VCSE Chair Meeting.

Action: PHP to adopt funding recommendations and forward to ICB pending OED approval.

4 Eastern Devon Population Health Finances

 PS presented the 2023/24 financial summary, noting an underspend of £21k, including £2k received from DCC. A small underspend is expected again for 2024/25. VAT recovery had minimal impact. Due to sustainability issues, RDUH will now top-slice future allocations, reversing the previous practice of absorbing central costs.

 End-of-year reporting for funded projects was emphasised, with AS coordinating updates including user impact stories and ROI. SLG noted she had videos to contribute with privacy concerns.

Action: PS/IV to prepare 2-year financial reconciliation report for June OED meeting.

Action: Project leads to submit end-of-year reports to AS.

Action: PS to agree deadline with SLG for media submissions.

5 Roadmap for Devon's Neighbourhood Health Services

- LH shared an update on the Neighbourhood Health Services roadmap, which
 aims to integrate services around communities and individuals. Drawing on
 learning from Cornwall's experience, she noted the need for a flexible, LCP-led
 configuration in Devon. Eastern Devon lacks an obvious pre-existing structure,
 unlike other LCPs (e.g., Plymouth's Health and Wellbeing Hubs or North's One
 Community Network).
- Key discussion points included ensuring CYP service inclusion, defining
 consistent terminology across organisations, and the importance of VCSE and
 Public Health input into the design process. Caroline Stead is leading the process
 for Eastern Devon, with input from the Steering Group due in six weeks.

Action: JC to organise design session on neighbourhood configurations with Caroline Stead and partners.

Action: LOL to liaise with Public Health to confirm Steering Group representation.

Action: FC/DH to coordinate VCSE Assembly engagement.

Action: MM to feedback on terminology and integrated working models.

Action: RF to lead formation of a community of practice for unpaid carers.

6 Any other business

JC thanked LH for her valuable contribution to the Eastern Devon Partnership and wished her success in her new role in Plymouth.
